The total number of Shares entitling the holders to attend and vote for or against resolutions no. 1 to no. 8 as set out above was 5,462,532,820 Shares. None of the shareholders of the Company (the “**Shareholders**”) were entitled to attend and required to abstain from voting in favour of or to vote only against the resolutions at the AGM.

There were no restrictions on any Shareholder to attend and cast their votes on any resolutions proposed at the AGM.

None of the Shareholders has stated their intention in the Circular to vote against or to abstain from voting on any of the resolutions at the AGM.
